The DD Council EI grant, "Bridging the Gaps in Early Intervention Services in Ohio," will be distributing a survey to all counties in the coming days. This survey is a follow up survey to one completed in 2012. I fully support this effort and strongly encourage your participation.

PROGRAM UPDATES

SFY16 45 Day Baseline

Activities related to the SFY16 45 Day baseline analysis are underway. Missing data inquiries and verification requests were sent to applicable counties June 8 and are due back to Melissa Courts, EI Monitoring Consultant, at melissa.courts@odh.ohio.gov by June 23.

COS Progress Questions Reminder

As explained in the Help Me Grow Early Intervention Program Updates #1603 and #1604, in the February 17 Early Track release, additional questions regarding child outcomes were added to the exit page. For all three outcomes areas, the following question was added: "Has the child shown any NEW SKILLS or BEHAVIORS related to [outcome area] since the last Child Outcomes Summary rating?" At the time, we asked that counties go into Early Track records of children who exited between July 1, 2015 and February 16, 2016 and add this information. A list of relevant children was sent to each county on April 13. Data will be pulled for the SFY16/FFY15 child outcomes analyses for the Annual Performance Report (APR) indicators in early August, so if you have not yet done so, please enter progress data for as many of those children as possible. SFY 17 Service Coordination Grant

DODD will become the Part C lead agency with the start of the SFY17 Service Coordination grants. However, the grant terms and conditions, policies and procedures are still those contained in the Department of Health's OGAPP manual, per the Continuation of Funding Application, for the entirety of the grant year (July 1, 2016 through June 30, 2017). DODD will be reimbursing subrecipients on the reimbursement timeline (quarterly or monthly) that subrecipients selected as part of their application for the continuation of funding. ODH has historically provided subrecipients with an *estimate* of the breakdown between federal and GRF funds. DODD does not provide estimates, but will provide any federal grant recipient with a breakdown of federal and state funds paid to the grant recipient so the recipient can complete A-133 reporting. This usually happens in concert with each entity's fiscal year and the information is provided after payments are made for the previous year. Fiscal questions (including those related to GMIS, expenditure reporting, etc.) throughout the grant year may be directed to Tiffany Harlan at tiffany.harlan@dodd.ohio.gov.
