PROGRAM UPDATES

Door Hangers

We were recently asked if a leaving a door hanger for a family receiving EI services who is not at home for an appointment is a violation of the Health Insurance Portability and Accountability Act (HIPAA). Under HIPAA's privacy requirement (45 CFR Part 160 and Subparts A and E of Part 164), those with access to protected health information (PHI) must take steps to secure the information. PHI includes any individually identifiable information about physical or mental health conditions, any health care (services, treatments, diagnostic tests, etc.), and payment made for or on behalf of the child if it can be directly or indirectly linked to the child. PHI also includes demographic information and common identifiers, such as name, address, and birth date, if those identifiers can be associated with the child's health information.

DODD is concerned that a child's PHI could be compromised by leaving an Early Intervention door hanger at the child's home because someone other than the child or the child's representative could see the door hanger and associate that child as receiving Early Intervention services. A missed appointment door hanger that did not name the child nor indicate that the appointment involved the Early Intervention program would likely not constitute a problem. IN THE SPOTLIGHT: FAMILY OUTCOMES

General Guidance about IFSP Outcomes

All IFSP outcomes are based on information gathered from the complete functional assessment process. This information should be used by the IFSP team to ensure that outcomes are based on the family/caregivers identified priorities, resources and concerns. The outcomes must reflect how young children learn and the changes that the family/caregiver desires in order to support their child's development. IFSP outcomes are measurable, contextualized, discipline and jargon free, emphasize the positive and focus on active participation.

Questions and Answers about Family Outcomes

Question: What is the difference between family-focused outcomes and child focused outcomes?

Child-focused outcomes are family and caregiver priorities that focus on the child's active participation within an existing or desired activity setting or routine. The child is the learner, and the outcome promotes the child's acquisition of new skills and knowledge, independence, and engagement.

There are two types of family-focused outcomes: participation based and resource based outcomes. Family-focused, participation based outcomes focus on the ability of the family/caregiver to promote their child's active, functional participation in desired/needed activities and routines. Resource based outcomes support families with enhancing their capacity to meet the needs of their child, including supporting families with accessing formal or informal supports. Family-focused participation based and resource based outcomes focus on the family/caregiver as the targeted learner.

Question: Are Ohio IFSP Teams allowed to write family focused outcomes?

Yes. The IFSP Team is to develop high quality functional IFSP outcomes that clearly address the priorities, concerns, and needs of each family. Sometimes, this process will lead the IFSP Team to identify child-focused outcomes, while other times the team will identify family-focused outcomes, and at still other times, developing both types of outcomes.

Question: How do we document a family focused outcome on the IFSP?

A family focused outcome would be documented on Section VI of the IFSP like any other outcome.
