PROGRAM UPDATES

EI Local Outreach Funds

All FCFC coordinators and EI contract managers will be receiving an e-mail within the next two weeks outlining additional details about the funds DODD will be providing for local outreach for EI. This e-mail will explain the reporting requirements and restrictions on how the funds may be used. We have received several questions in the past month, and this upcoming communication seeks to answer those questions. For additional details about these funds, please see Program Updates #1721.

EI 8045 Referral Form

We would like to remind everyone that the EI 8045 is one option for immediately pushing through an EI program referral when a family calls a service coordination agency with a concern about their child's development. Cleveland Sight Center will process these as an automatic EI program referral upon receipt of the form from the SC agency. We have received some suggestions from locals about ways the form could be improved, and we are planning on releasing an updated form incorporating some of these suggestions on September 29. If you have any enhancements you would like to see with the form, please e-mail nathan.dedino@dodd.ohio.gov. The two suggestions we have heard most frequently from locals is adding optional fields for ETID number (if known) and a field to note some specifics about the family's concern.

Early Intervention Data System EI Referral Transfer

DODD IT staff are continuing to work to resolve the bug in the transfer of EI records from Early Track to EIDS. We understand that this has been a burden on counties and apologize for the inconvenience. IT staff believe that they are very close to implementing a final resolution to this bug. We anticipate this to go live sometime September 18 or 19. We will continue to provide updates in the EIDS message box. In the meantime, please continue to access new referrals in Early Track and begin the intake process. When these records are successfully transferred from Early Track to EIDS, their referral dates will reflect those in Early Track.

Creating an EIDS Account

For new EIDS users, part of the process of gaining access to EIDS involves creating a DODD portal account. For users who currently have a DODD portal account for another application, it involves requesting that EIDS be added to their current account. *Once you have received confirmation about your DODD portal account, please forward your confirmation e-mail to EIDS@dodd.ohio.gov*. There is one final step that we need to complete within the EIDS application to finalize your account access.

If you have any questions about how to set up your, feel free to get in touch with us at EIDS@dodd.ohio.gov at any time. Since not all EIDS users have signed up to receive the biweekly Program Updates, please be sure to pass this information along to relevant staff.

Service Coordination Credential

The Ohio Professional Registry (OPR) will be sending out renewal notices approximately 90 days prior to the expiration of the Service Coordinator and Supervisor of Service Coordinators credentials. The e-mails will be sent out by September 20, 2017 for November and December expirations. For this first month, OPR will also include September and October expirations in order to notify all upcoming renewals. In order to receive these notifications, please log into your Registry Profile and verify that your e-mail address is accurate. There are several accounts and functions at the OPR with unique e-mail addresses. Please add system@occrra.org and credential@occrra.org to your safe sender list in order to receive any and all e-mails from the OPR. Remember: these reminder e-mails are a courtesy. If you do not receive the e-mail reminder, you are still responsible for renewing your credential by its expiration date.

Have you updated your employment in the Ohio Professional Registry? The registry is the system of record for you to keep track of your employment history but it must be kept up-to-date and all entries must include a start and end date (if applicable). Be sure you select a primary role as well as a primary employment so that your profile is accurate and that your credential is pulling correct information.
