### PROGRAM UPDATES

## 2018 Family Questionnaire

DODD mailed the 2018 Family Questionnaire to all families who had an active IFSP on June 1 last month. The surveys are due back October 1. Contract Managers and FCFC Coordinators were sent a list of families in their county who received a questionnaire. We ask that you encourage any families who have not yet completed and returned the questionnaire to do so, as their feedback is very helpful in ensuring a high quality EI system in Ohio.

Families may choose to complete the paper survey and return via mail or respond online through Survey Monkey. As in past years, all counties will receive a report including a summary of the responses from families in the county, including comments.

Please feel free to share the link for the family survey with the families you are serving who had an active IFSP as of June 1, 2018. They will need to enter their child's ETID in order to complete the survey, which is found on the upper right corner of the paper survey or their IFSP.

# Service Coordinator/Service Coordination Supervisor Credentialing: Verifying Degrees and Obtaining Transcripts

Early Intervention Service Coordinators and Service Coordination Supervisors are credentialed through the Ohio Professional Registry (OPR). Candidates must submit documentation of their education to show that credential requirements are met. Please use the following resources if you are unable to receive an official transcript or need guidance to verify that your education meets requirements of the Ohio Early Intervention credentialing rule.

- If you have completed a degree but are unable to receive an official transcript, you may be able to obtain degree verification using the National Student Clearinghouse (<a href="https://studentclearinghouse.org/">https://studentclearinghouse.org/</a>). Some colleges and universities provide the Clearinghouse with graduation information.
- To determine if a US college or university is accredited, use the Database of Accredited Postsecondary Institutions and Programs (https://ope.ed.gov/dapip/#/home).
- Requirements for verification of international education are found on the OPR's International Education Guidance Document (<a href="https://occrra.org/wp-content/occrra/opr/opr-international-education-evaluation.pdf">https://occrra.org/wp-content/occrra/opr/opr-international-education-evaluation.pdf</a>). For review of post-secondary education (college/university), please upload the following documents as one entry into your profile:
  - A translation or evaluation stating professional name, school name, US degree equivalency and major area of study as well as the confer date. This document must be notarized.
  - Original document
