### **FFY18 Annual Performance Report Posted for Public Comment**

A draft of Ohio's FFY18 Part C Annual Performance Report (APR) was posted on the EI website November 7. You can access the draft here:

## **MyLearning Update**

The MyLearning leaning management system has recently undergone updates. These include the following:

- The home page has a new look and includes FAQs.
- Users may browse the catalog of trainings without logging in, but must login to enroll in a course.
- All courses are mobile compatible (Android phone, iPhone, tablet, iPad)
- The search feature has been improved. You can search for courses by name, keyword or course number.
- A transcript feature will gradually replace individual certificates. The transcript has page breaks below each course so users may print individual pages to submit for credentialing.

## **EISC and EISC Supervisor Credential Applications**

We have added an instructions document for the Ohio Professional Registry (OPR) to the website. The document explains how to apply for an EI service coordinator or EI service coordinator supervisor credential and how to check the status of credential applications. ## How to Apply for a Early Intervention Service Coordinator or Early Intervention Service Coordinator Supervisor

1. Create a profile in the Ohio Professional Registry  
<https://registry.occrpa.org/user/register>
2. In your registry profile – upload required trainings to the Training tab
3. In your registry profile – upload required education to the Education tab
4. In your registry profile – access the application via the Applications tab of the registry profile.
  - a. If you currently do not hold a credential, select which application you are applying for. You have the option to choose one of the following:
    - i. Early Intervention Service Coordinator 1-Year
    - ii. Early Intervention Service Coordinator 5-Year
    - iii. Early Intervention Service Coordination Supervisor-1-Year
    - iv. Early Intervention Service Coordination Supervisor-5-Year
  - b. If you are a currently credentialed professional, scroll down to the application menu below, choose the current application that is approved for the current timeframe, click action and select renew. This will take you to the “transition” application that is valid for 5 years.
5. In the application, complete all fields in the Applicant Information sections.
6. In the Training Requirement section, select the corresponding trainings in the drop down. Trainings need to be verified in your profile for them to show up in the drop down.
7. If applicable: in the attachments section upload employment letter for EISC agency or DODD provided employment verification form stating applicant is employed by or under contract with an Early Intervention service coordination agency.

If applicable: Non-agency approved major requires at least two years of verified full-time (or equivalent part-time) supervised, paid experience as referenced in rule 5123-10-04.

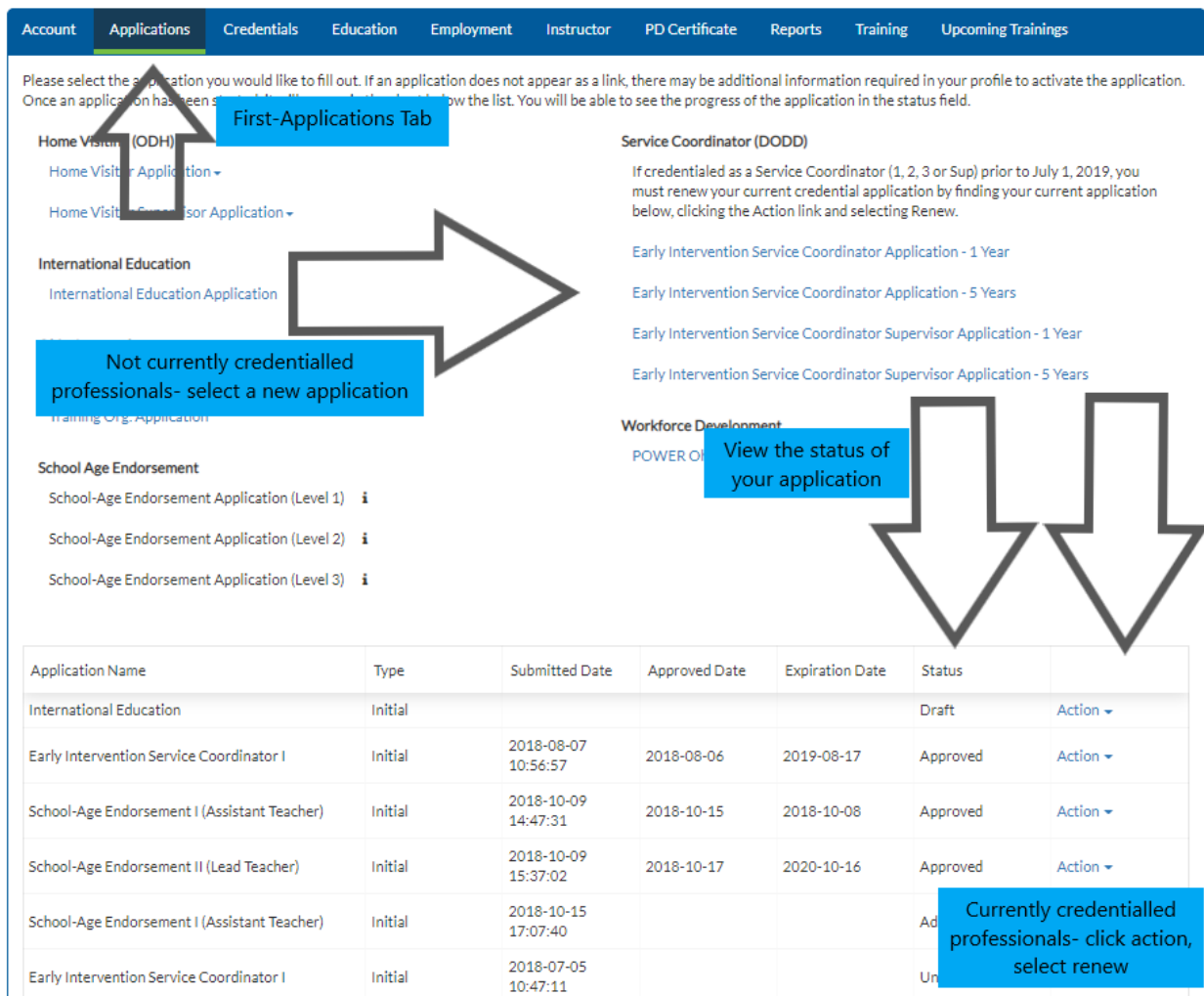
If applicable: Training waiver(s).

8. Click on Submit Application

For information about the application’s verification process, refer to the Status in the Applications tab for information. **\*The application chart WILL NOT display when using Internet Explorer, therefore we require use of Google Chrome or Mozilla Firefox.**

The following Status may display:

1. Draft – application was started, but not submitted for review
2. Submitted – application is submitted and waiting for review
3. Unable to verify – credential cannot be issued
4. Approved – credential has been issued or renewed
5. Add'l Info – applicant needs to take additional action to fulfill the requirements of the credential. Hover over the “i” for guidance notes.
