Activities related to the SFY22 TRS baseline analysis are complete. Results memos were sent to applicable counties October 26.

SFY23 Timely Receipt of Services (TRS) baseline activities will begin this month for Group 3. Applicable counties will have until November 30 to review their data in the EI Data System (EIDS) to ensure data are up-to-date and accurate.
