PROGRAM UPDATES

Timely Receipt of Services (TRS) Baseline

Activities for the SFY24 TRS baseline will begin soon. Each county will receive an email regarding their inclusion in the analysis later this month. SFY24 45-Day Baseline

The SFY24 45-Day Timeline baseline activities are underway. Data were extracted December 20 and compliance inquiries were sent to all participating counties on January 9. All inquiries are due January 24.

SFY24 LEA Notification Baseline

The February 1 Quarterly LEA Reports are used for the state's annual compliance analysis related to LEA notification. DODD is responsible for issuing findings of noncompliance in this area where appropriate. The February 1 Quarterly LEA Report may be run no earlier than January 22 and must be sent to the appropriate LEAs no later than February 1. *You must also email a copy of the full report to DODD no later than Friday, February 2.* Submit reports to Erin.Hale@childrenandyouth.ohio.gov. You are strongly encouraged to maintain a copy of the report in the event that it is needed at a later date for monitoring purposes. DODD sent an email explaining the LEA reporting requirement to all EI contract managers and FCFC coordinators on January 5. Please remember that parent rights apply to any shared information if personally

identifying details are disclosed. Only applicable pages of the report should be sent to each LEA.

Service Coordination Oversight Report – Additional Guidance

As you begin preparing your service coordination oversight report, you will notice that the referral categories on the report template are not an exact match to those on the EIDS referral extract report. Meet Your Presenter: Mishka Terplan, MD, MPH, FACOG, DFASAM



Mishka Terplan is board certified in both obstetrics and gynecology and in addiction medicine. His primary clinical, research, public health, and advocacy interests lie along the intersections of reproductive and behavioral health. He is Medical Director at Friends Research Institute and adjunct faculty at the University of California, San Francisco where he is a Substance Use Warmline clinician. Dr. Terplan has active grant funding and has published extensively on health inequities, discrimination, and access to treatment and is internationally recognized as an expert in the care of pregnant and parenting people with substance use disorder. He has spoken at local high schools and before the United States Congress and has participated in federal and international expert panels primarily on issues related to gender, reproduction, and addiction.

Webinar Overview

During this webinar, we will review the history of substance use in pregnancy with particular attention to opioids. We will discuss medications for opioid use disorder with emphasis on parenting and recovery. Basic principles of care will be contrasted with the actual landscape of available services. The role of collaborative care and the importance of the MAT provider will be stressed, in particular with the development of Family Care Plans and the postpartum period. Overall the talk will be grounded in best medical practice and respect for human dignity.
