### **State Targets**

• The U.S. Department of Education has established a target of 100% for all compliance indicators. Ohio established statewide targets for performance indicators in the State Performance Plan (SPP) submitted to the U.S. Department of Education's Office of Special Education Programs (OSEP) in January 2022.

#### **Other Notes**

- For each of the indicators, N/A denotes an item as "Not Applicable," indicating there were no data for the item
- Ohio continued to use a cyclical monitoring approach where each county was included in one of the three compliance analyses. Montgomery County was selected for the 45-Day indicator analysis for SFY22.



The assigned determination of Montgomery County is **Meets Requirements**.

#### **Counties were determined Needs Assistance if:**

- They were issued a PIP based on issues identified during the fiscal year <u>OR</u>
- Their compliance percent was less than 100% in any of the compliance indicators AND
- Their score for performance indicators was less than half of the total score possible (11 total possible points, as described in the memo)

#### **Data Summary**

- TRS: All children with services due to start between January 1, 2022 and March 31, 2022
- 45 Day: Children with 45-Day timelines ending July 1, 2021 through September 30, 2021
- Transition Steps and Services: Children who had Transition Steps and Services due between October 1, 2021 and December 31, 2021
- **Notification to LEA and SEA:** Children reported to the relevant LEA who would be turning three between February 1, 2022 and January 31, 2023
- TPC: Children who had a TPC due between October 1, 2021 and December 31, 2021
- **Services in Natural Environments:** Infants or toddlers served on December 1, 2021 who were receiving the majority of services in the home or in community-based settings
- Child Outcomes: Scores from entry and exit COS statements of children who exited between July 1, 2021 and June 30, 2022 and were served in Early Intervention for at least six months indicating those who (1) substantially increased their growth or (2) exited at age expectations in relation to (a) positive social-emotional skills, (b) acquiring and using knowledge and skills, and (c) taking appropriate actions to meet their needs
- Family Outcomes: Scores of respondent families who were being served in Early Intervention on June 1, 2022 who reported that early intervention services have helped the family (a) know their rights, (b) communicate their children's needs, (c) help their children develop and learn
- **Birth to 1 Child Count:** Number of children under the age of one served on December 1, 2021 compared to the 2020 population estimate
- **Birth to 3 Child Count:** Number of children under the age of three served on December 1, 2021 compared to the 2020 population estimate
