State Targets

Ohio established statewide targets for performance indicators in the State Performance Plan (SPP) submitted to the U.S. Department of Education's Office of Special Education Programs (OSEP) in January 2022.

Other Notes

- For each of the indicators, N/A denotes an item as "Not Applicable," indicating there were no data for the item.
- Ohio continued to use a cyclical monitoring approach where each county was included in one of the three compliance analyses. Allen County was selected for the 45-Day indicator analysis for SFY25.

The assigned determination of Allen County is **Meets Requirements**.

Counties were determined Needs Assistance if:

- Their compliance percent was less than 100% in any of the compliance indicators **AND**
- Their score for performance indicators was less than half of the total possible score (nine total possible points, as described in the memo)

Data Summary

- **TRS:** All children with services due to start between October 1, 2024 and December 31, 2024
- **45 Day:** Children with 45-Day timelines ending January 1, 2025 through March 31, 2025
- **Transition Steps and Services:** Children who had Transition Steps and Services due between October 1, 2024 and December 31, 2024
- **Notification to LEA and SEA:** Children reported to the relevant LEA who would be turning three between February 1, 2025 and January 31, 2026
- **TPC:** Children who had a TPC due between October 1, 2024 and December 31, 2024
- **Services in Natural Environments:** Infants or toddlers served on December 1, 2024 who were receiving the majority of services in the home or in community-based settings
- **Child Outcomes:** Scores from entry and exit COS statements of children who exited between July 1, 2024 and June 30, 2025 and were served in Early Intervention for at least six months indicating those who (1) substantially increased their growth or (2) exited at age expectations in relation to (a) positive social-emotional skills, (b) acquiring and using knowledge and skills, and (c) taking appropriate actions to meet their needs
- **Family Outcomes:** Scores of respondent families who were being served in Early Intervention on March 1, 2025 who reported that early intervention services have helped the family (a) know their rights, (b) communicate their children's needs, and (c) help their children develop and learn
- **Birth to 1 Child Count:** Number of children under the age of one served on December 1, 2024 compared to the 2023 population estimate
- **Birth to 3 Child Count:** Number of children under the age of three served on December 1, 2024 compared to the 2023 population estimate
