CENTRAL INTAKE SOUTHERN REGION CHANGE

- The Pike County Board of Developmental Disabilities (PCBDD) no longer serves as the Help Me Grow Central Intake & Referral (CIR) provider for the Southern region. As of July 17, the counties from the Southern region were redistributed into the Central, Southeastern, and Southwestern regions:
 - Action for Children (AFC) in the Central Region is now covering 10 counties, adding Fairfield and Pickaway.
 - Butler County Educational Service Center (BCESC) is now covering 13 counties, adding Lawrence, Pike, Ross, and Scioto.
 - Noble County Health Department (NCHD) is now covering 19 counties, adding Athens, Gallia, Hocking, Jackson, Meigs, and Vinton.
- Bright Beginnings emailed EI and Home Visiting (HV) providers and referral sources this
 information on July 16 and the Help Me Grow website has been updated to reflect the new map.

CHILDREN AND YOUTH ADVISORY COUNCIL

- DCY stakeholder group Established this budget cycle
- Early Intervention will be part of a subcommittee of this council
- All requirements for the state interagency coordinating council, as described in 20
 U.S.C. 1441 will be met
- Details, including schedules and membership, for the council and subcommittees are being finalized and will be communicated upon completion
- We anticipate the November 5 El Advisory Council meeting to occur as planned



El Technical Assistance (TA) and Practice Advancement Updates

EI TECHNICAL ASSISTANCE (TA) AND PRACTICE ADVANCEMENT

- Program Consultants (PC)-Updates
 - Principles of Service Coordination (POSC) Module 3- All EISC, EISC
 Supervisors, CMs required to complete by Dec 31, 2025
 - System of Payment
 - Review and Revise the Individualized Family Service Plan (IFSP) guidance
 Documents along with other Guidance Document revisions
 - TA and Training Plans will include IFSP and Teaming Process And Assessment Practices
 - Regional program consultants- Map changes to be announced October 1st
 - Assessment practices



POSC MODULE 3

- POSC Module 3 Training Requirement
- All EISCs, EISC Supervisors, and Contract Managers must complete POSC Module 3 (EI-042) by December 31, 2025.
- New hires must complete all POSC modules, including Module 3, as part of the EISC credentialing process.
- Completion data will be collected in the SFY26 mid-year program report.
- Agencies are encouraged to plan ahead to ensure timely compliance.

IFSP GUIDANCE DOCUMENT AND OTHER GUIDANCE

- IFSP Guidance Review Update
 - Program Consultants are reviewing the IFSP guidance and related documents
 - Focus: Clarity and alignment with recent rule changes
 - Updates will be shared once the full review is complete
 - Making only necessary changes
 - Releasing updates all at once
 - Ensure the entire field is using the most current and accurate guidance



PROGRAM CONSULTANT MAP

- Consultant changes:
 - Cory St. Myers the new Program Consultant will begin reaching out to counties in the coming weeks.
 - Warm hand-offs
 - PCs are scheduling joint visits, trainings, and discussions to support a smooth transition
 - Once the regional map changes, an updated version will be shared with the field.
- Mentorship
 - As part of our onboarding structure (a year long process) new hires will:
 - Work with a mentor throughout their first year
 - Spend 4 months with each existing Program Consultant for guided mentorship

Developmental Specialist (DS) certification processing transitioned to OCCRRA through the Ohio Professional Registry (OPR) on March 3, 2025.

DEVELOPMENTAL SPECIALIST CERTIFICATION UPDATES

- Several PIPs have been issued recently due to DS certifications that have expired
 - Issued when DS fails to meet requirements and/or apply for recertification prior to the expiration date of their certification
- DS certification is a 2 Step Process
 - Creation of OPR Profile and upload of required documents (30 days)
 - Submission of DS application (additional 30 days)
 - Reminders went out in Tuesday Times and <u>DS FAQ Document</u>
