MESSAGE FROM THE PART C COORDINATOR

We recently sent each county a file including open-ended responses provided by families in their county on the 2025 EI Family Questionnaire. Additional information about these files is included in today's first update. I wanted to again thank you all for all of your work in engaging families in this process, and, more importantly, the work you do to support these children and families each and every day. As I have said before, the Family Questionnaire is one of my absolute favorite aspects of this job, especially reading the open-ended responses. I have shared a handful of quotes below (with identifying information removed) from responses we received to this year's questionnaire that particularly highlight the incredible impact your work makes on the children and families we serve.

"My daughter has a lot of uncertainty surrounding her medical care and diagnosis. El helped me first and foremost focus on the development of my child and to prioritize her care. Our development specialist came to our house to help my daughter's development, but supported our entire family with education, resources, experience, and confidence to be comfortable with the unknown."

"The comradery of the entire team has been both extremely welcoming and helpful. I truly felt welcomed onto a team and it was a group I felt genuinely cared about my child and his development. Coming into our home felt comfortable and easy while also being highly effective. Everyone on our child's care team were extremely good at their jobs while also being all around good humans. Our experience has been nothing but positive and we are very thankful for the program and the people within it!"

"EI has been hugely beneficial to my family in simply helping me better understand my child's diagnosis and what her strengths and weaknesses are surrounding it. They have helped prepare me for little things I should expect and been a great support for me with any questions or concerns I have. They are proactive in helping me meet personal goals with my daughter and also at meeting goals set in our IFSPs. They never rush and are always available if I need them during our visits or even just via text. I feel like our service providers are an extension of our family!"

"The entire experience has been amazing. From the compassionate providers to the personalized support, every part of the program has helped our family feel seen, supported, and empowered. The way our son is met with patience and understanding has truly made all the difference."

"One of the things that has worked really well for our family in early intervention has been having a consistent team that truly listens and collaborates with us. The individualized support, especially from our therapists and coordinators, has made a huge difference in helping us understand some of our child's needs and how to support her progress at home. Having regular check-ins, goal setting that actually reflects our concerns, and strategies that fit into our daily routine have all helped reduce stress and build confidence."

2025 EI Family Questionnaire Comment Files

El Office Hours

Thank you to everyone who attended our inaugural EI office hours on September 29, covering the EI System of Payments (SOP), and introducing a new form to be used for requesting the support of Councils of Government (COGs) or Department Contracted Providers (DCPs) for evaluations and assessments or ongoing EI services. The slides and recording from this event will be available on the EI website in the coming weeks.

We will have two more EI Office Hours sessions this year on October 27 and November 24. During the October office hours, we will continue our discussion around the new Request for COG or DCP Support form. The topic for the November office hours will be announced soon. New Mandated Reporter Training

As indicated in the September 30 EI Program Update, DCY created a new mandated reporter training that EI Service Coordinators (EISCs), EISC supervisors, and Developmental Specialists (DSs) will be required to take to meet their initial credential training requirement. Beginning November 1, the DCY Child Abuse and Neglect Recognition and Mandated Reporting Requirements training will replace EI-067 in MyLearning and will be and will be available here.

November 1st LEA Reporting

The quarterly LEA reporting requirement is coming up at the end of the month. Under Ohio Administrative Code (OAC) 5180-10-02(L)(1)(a), the EI service coordination agency must notify the LEA of children who will turn three within the next year by the first day of February, May, August, and November. This report can be accessed in the EI Data System (EIDS) in both Excel and PDF formats. Either version may be used, but please remember the following:

- The November 1 LEA report must be run no earlier than October 22 and no later than November 1.
- It is not acceptable to physically change the LEA report before sending it to the school district, such as crossing names out or adding a name by hand. All changes must be made in EIDS.
- It is expected that child information will be updated in a timely manner so that the LEA reports in EIDS are accurate.
- Only the sections of the report that are relevant to a particular LEA should be sent to that LEA, not the entire report.

If you are not sure which LEA should be selected for a specific child, we encourage you to contact the relevant educational service center (ESC) for clarification. Contact information for all of the ESCs and public school districts, along with a map of districts, is available here: http://education.ohio.gov/Topics/Data/Ohio-Educational-Directory-System-OEDS. This quarterly report must be provided to the LEAs no later than Saturday, November 1. A copy of the report does not need to be submitted to DCY, but we encourage you to maintain a copy of the report in the event that it is needed at a later date for monitoring purposes.
