SFY16 LEA Baseline Results

February 1 reports are used for our annual compliance analysis of quarterly LEA reporting. *We are happy to report that all of Ohio's EI local programs achieved 100% compliance with this indicator for SFY 2016!* Memos were sent out last week by Zoe Smoot. May 1 Quarterly LEA Reports

Be reminded that the May 1 LEA quarterly report requirement is approaching. The report may be run no earlier than April 21, 2016 and must be sent to the LEAs no later than May 1, 2016. Please do **not** submit copies to ODH, but you are encouraged to maintain copies on file.

SFY16 45 Day Baseline

Activities related to the SFY16 45 Day baseline analysis will begin at the end of April. Notification memos went out earlier this week identifying which programs will be participating and outlining timelines. For those included in the 45 Day analysis, the data cleaning period runs from April 22 through May 6. Data extraction will occur on May 20.

SFY16 TRS Baseline

Final data analyses are currently underway and results memos will be sent out to participating programs in late April.

Last Call for Family Questionnaire Feedback!

To ensure collection of the most useful and meaningful data possible, we will be revising the 2016 Family Questionnaire, and we would like your feedback. If you have any suggestions or comments about this year's questionnaire, please email EI Researcher, Cydney Hoffman, at Cydney.Hoffman@odh.ohio.gov by Monday, April 18. The questionnaire used for last year is attached for reference.

SFY15 Child Outcomes Data

In the February 17, 2016 Early Track release, additional questions regarding child outcomes were added to the exit page. This change was explained in greater detail in communication #1603. For all three outcomes areas, the following question was added: "Has the child shown any NEW SKILLS or BEHAVIORS related to [outcome area] since the last Child Outcomes Summary rating?" Since February 17, these data have been required in all circumstances the other Child Outcomes Summary questions are required, but *we are asking that counties go into records of children who exited between July 1, 2015 and February 16, 2016 and add this information*. Each county received a list of relevant children earlier this week. We do understand that this will be challenging for some counties, and we apologize for this bug being introduced into Early Track. We know that it may not be possible to enter data for all children, but please do the best you can as the answers to these questions do play a role in our APR reporting and the state's determination from OSEP. SFY16 Child Count and Settings Data

Ohio recently submitted SFY16/FFY15 Child Count and Settings data to OSEP. For the reporting year, the state Settings percentage is 95.64%, meaning nearly 96% of our children have the majority of their services occurring in natural environments. This is up almost 10% from last year

(which was up 6% from the previous year)! These data include all children who had an active IFSP on December 1, 2015. Primary service location for each IFSP is calculated by looking at total number of planned minutes of services per setting, as documented on the IFSP in Early Track. Thus, the settings percentage reflects the percentage of children with the majority of planned service time occurring in home or community settings. These data will be reported in Ohio's FFY15 APR, which is due to OSEP February 1, 2017.

Additionally, in response to requests from counties to have access to data in a timelier manner, instead of waiting until we submit the FFY15 APR in February 2017 to share these data, we are creating one page reports for each county that summarize their SFY16/FFY15 Child Count and Settings data. These reports are expected to be completed and distributed to counties in the next several weeks.

IFSP Guidance Document Erratum

We recently discovered an error in the IFSP Guidance Document around when to develop transition outcomes. The error is under the Transition Outcome section at p32, fourth paragraph. We are also taking this opportunity to provide some additional guidance around documentation and transition outcomes.

The guidance should read as follows:

Transitions can and do occur at many times so best practice indicates that transition should be a topic of conversation with the family and the other team members from the beginning of the family's journey in EI. However, a transition outcome does not have to be included in the IFSP until the child is at least two years and three months old. (3701-8-7.1(4)(a)).

For some children you will be doing a periodic review when developing the transition outcome. Documentation of this review should be done in the service coordinator's and/or provider's case notes, since the review section is not included on this outcome. Additionally, the transition outcome must be functional and contextualized and meet the 6 step criteria.
