## **EI Services for Children Who Are Deaf or Hard of Hearing**

As discussed in previous communications, DODD has transitioned EI services for children who are deaf or hard of hearing (D/HH) to a different structure from the Regional Infant Hearing Program (RIHP). DODD has contracted with six agencies that will provide the EI service of family training to families who have a child who are D/HH if the functional assessment and IFSP team determine that service is needed to meet an outcome on the IFSP. These providers and their regions accompany this bi-weekly communication.

The process differs somewhat from how it functioned under RIHP. Effective immediately, ODH will make a system referral to the relevant Central Coordination site when ODH learns of a child who has been diagnosed as D/HH. Central Coordination will then have the usual 14 days to make three contact attempts to the parent to determine if the family is interested in an EI program referral. If the family is interested in EI, a program referral to the county SC agency will be made.

It will then be the responsibility of the SC to assemble the appropriate personnel to complete the functional assessment and coordinate the IFSP meeting. For children who are D/HH, we would anticipate that the contractors for family training would, at a minimum, typically be involved in the functional assessment and IFSP processes. If the IFSP team determines that family training is needed to meet an IFSP outcome, the contractor may be the appropriate provider for the service. Alternatively, if the contractor is not the primary service provider, the contractor may be working as a secondary service provider and supporting the PSP through the teaming process.

## **SFY16 Transition Baseline**

Activities related to the SFY16 Transition baseline analysis are underway. For those included in the Transition analysis, the data cleaning period ran through August 15. Any needed data re-entry following deletions needed to be completed by August 26 and data extraction occurred August 29. County inquiries, including Steps Self Assessments, and missing data and verification requests (as applicable) are scheduled to be sent September 12.

## **Frequently Asked Questions about Secondary Service Providers**

As a follow up to the discussion of the Primary Service Provider (PSP) in communication #1617, the following frequently asked questions about the Secondary Service Provider (SSP) are presented. If you have additional questions, please follow up with your EI program consultant.

*Question 1: What is the role of the secondary service provider?*

*Answer:* The purpose of involving a secondary service provider is to provide role assistance to the PSP. Role assistance may include the following activities:

- Sharing additional expertise and knowledge to support the PSP, parents, and caregivers.
- Conducting further functional assessment

- Providing support to the PSP when the PSP believes that he or she needs additional ideas, resources, or direct assistance.

*Question 2: When are joint visits necessary?*

*Answer:* Joint visits are necessary in the following circumstances:

- The PSP has an issue that cannot be addressed within a team meeting.
- The SSP has questions that cannot be answered without direct observation of the child/family or directly observing the actual routine and/or activity setting.
- Assistance is needed that is outside of the PSP's knowledge, skill, or scope of practice. Examples might include constructing hand splints, assessing and supporting the family with adaptive equipment and modifications, etc.
- The parent requests access to a team member other than the PSP.

*Question 3: Do these visits have to be joint visits?*

*Answer:* Yes. When a team is implementing a PSP approach to teaming, the SSP delivers services jointly, at the same time and place with the PSP. This practice is helpful and supportive to both the family and PSP. The SSP should visit a family alone only if a PSP is unable to make a scheduled joint visit due to an unforeseen circumstance and the two professionals could not reschedule in time to meet timely receipt of services, and/or the family/child is in urgent need of the SSP's expertise. In these rare circumstances, the SSP and the PSP would need to meet to debrief as soon as possible following the SSP's visit with the family.
