Service Coordinator Credential Renewals

If you have recently applied for renewal of your Service Coordinator credential and have not received a response, please be advised that the renewal process is a *two-part process*. This is a change from prior years. You must complete both steps before your renewal application will be reviewed.

Step One: Submit certificates for the required trainings for your level of credential.

<u>Step Two</u>: Submit a renewal application by following the below steps:

- Submit the application.

February 1 LEA

The February 1 Quarterly LEA Reports are used for our annual compliance analysis. DODD is responsible for issuing findings of noncompliance in this area where appropriate. The February 1 Quarterly LEA Report may be run no earlier than January 22, 2017 and must be sent to the appropriate LEAs no later than February 1. You must also submit a copy of the report to DODD no later than Thursday February 2.

You are strongly encouraged to maintain a copy of the report in the event that it is needed at a later date for monitoring purposes. An email explaining the LEA reporting requirement was sent to all EI contract managers and FCFC coordinators on January 5. Please contact Melissa Courts at melissa.courts@dodd.ohio.gov if you should have received this information, but did not.

We know that there is an issue with some records where the service coordinator's name is not appearing on the quarterly LEA report. The service coordinator's name is not a federal requirement, so please be sure to send the LEA report to your local school districts as is. We apologize for the inconvenience and will work to get a fix to the report for future reporting.

EI Report Uses Document

We have finalized a new resource to help you navigate some of the reports in Early Track and more efficiently and effectively use your EI data. The attached "EI Report Uses" document includes a description of included data, a screenshot of report parameters, suggestions for potential uses, and a list of the included fields for several reports. Many of you have already seen this resource, as it was utilized during the Data and Monitoring Road Show trainings in the Fall of 2016.
