# **Transition Outcomes**

Please remember that IFSP outcomes related to transition, like any other outcome, should be entered in the Early Intervention Data System (EIDS). When entering any outcome, please be sure to enter the complete text rather than the outcome number.

## SFY 2017 Timely Receipt of Services Baseline

### In the Spotlight: Non-Compliance Reasons

If a component of a compliance indicator (i.e., 45-Day, TRS or Transition) is late, an explanation is required and the data system will prompt you to select a noncompliance reason (NCR). There are five options from which to choose:

- 51: Parent/Child Reason
- 52: Couldn't locate/reach family
- 53: Emergency-related closure
- 54: HMG staff error
- 55: HMG system reason

The first three are "acceptable" NCRs and will not count against a program's compliance status. It is, however, important to have detailed documentation to support the NCR and show that the reason for the delay occurred prior to the required component's (e.g., evaluation, assessment, IFSP service start) due date. A parent/child reason can include family illness, the parent asking to reschedule or delay a visit, or any circumstance where the family is offered a timely appointment, but has declined that offer and/or has requested a later date.

A component may be late because the SC or other team members have been unable to make successful contact with the family. This could include leaving multiple messages that have not been returned in a timely manner, no-shows, phone numbers that are not in service, a visit in which the parent or child needs to be present and is not, or other situations in which a step cannot be completed due to lack of family response or participation. As long as these circumstances are thoroughly documented, the NCR will be considered acceptable.

An emergency-related closure (level 3 snow emergency, flooding, extended power outage, etc.) is an acceptable noncompliance reason when it clearly prevents an appointment from taking place. Documentation should be maintained that demonstrates the date and scope of the closure. Weather-related emergencies that impact only individual staff are not an acceptable reason for a late timeline.

While staff will naturally experience illness, car trouble, family emergencies and other unexpected events, appointments canceled by staff are considered a system error and not an acceptable reason for a delayed timeline by themselves. In these cases, another staff member may be able to fill in. Similarly, a lack of qualified staff, insufficient evaluation slots, miscommunication between agencies and similar issues are frustrating situations, but are also noncompliant NCRs when they result in late components. Finally, delays due to staff error, including situations such as a missed screening or simply overlooking a due date, are not acceptable reasons for a delay.

While it is important that children and families receive program components in a timely manner, it is also imperative that the IFSP process be conducted in way that is respectful to and supportive of the family. It is best to start the process as early as possible to allow for unexpected events. Families should not feel forced to accept dates and times that do not fit their schedule solely to meet a deadline. Families need to be offered flexibility, but program staff need to be able to document the scheduling process.
