Credential/License Reminder

With the beginning of the new year it may be a good time to check the credentials of your evaluators, assessors, and service coordinators. Evaluators and Assessors *must* have an active license or credential in order to meet highly qualified personnel to conduct EI evaluation and assessments. Service coordinators and supervisors of service coordinators *must* also maintain an active credential. Individuals with lapsed credentials and licenses are unable to perform activities within the EI system that require a license or credential. In addition, there may be sanctions if individuals perform these activities with a lapsed license or credential.
