Ohio Professional Registry Personnel Changes

Identification of a Parent in EI Guidance

DODD has created a more user-friendly version of the flow chart that service coordinators should use to identify who is a "parent" in Early Intervention. In addition, the guidance document accompanying the flow chart ("Parents and Parental Consent in Early Intervention") has been slightly revised to reflect the need to first examine a judicial order when determining who the parent is when a child's biological or adoptive parent is incarcerated. Referrals from ODH for Children Who Are Deaf or Hard of Hearing

The ODH Infant Hearing Program has contracted with the Ohio Coalition for the Education of Children with Disabilities (OCECD) to contact families with children who have been diagnosed as deaf or hard of hearing. OCECD will give a brief overview of EI and to determine if the family is interested in making a referral to EI. If the family is interested in the EI referral, OCECD will complete the EI 8045 form and submit to central intake, resulting in an EI program referral. As a reminder, Program Updates #1715 details steps service coordinators can take to obtain documentation of a hearing loss diagnosis directly from ODH.

August 1 LEA (all counties)

The August 1 LEA quarterly report requirement is approaching. The report may be run in EIDS no earlier than July 22, 2018 and must be sent to the appropriate LEAs no later than August 1, 2018. Please do *not* submit copies to DODD, but you are encouraged to maintain copies on file.

If you are not sure which LEA should be selected for a specific child (*e.g.*, foster care situation), we encourage you to contact the relevant Educational Service Center (ESC) for clarification. Contact information for all of the ESCs and Public School Districts, along with a map of districts, is available here:

SFY18 45-Day Analysis (Group 3)

Activities related to the SFY18 45-Day baseline analysis are scheduled to begin next week. Counties will receive an initial email regarding their inclusion in the analysis. For counties included in the 45-Day analysis, the data cleaning period will run from August 1 to August 15.

SFY18 Transition Analyses (Group 1)

Activities related to the SFY18 Transition Steps and Services and Transition Planning Conference (TPC) baseline analyses are underway. County inquiries were due back to DODD June 22. Verification and final analyses have begun, and results memos will be sent in early August.
