### **SOP Monitoring**

DODD has completed the initial review of SOP records submitted for counties who had initial IFSPs in September 2018. Similar to the baseline process used for compliance indicator analyses, DODD is providing a clarification period. Requests for additional information were sent to

applicable counties earlier this week, and are due back to DODD by Friday, January 11. Counties who did not have any records that needed clarification should have received an email to indicate no further information is needed at this time. Counties that did not have applicable records from the first data extract have since received a records request or will receive a records request when applicable records are identified. ### **EIDS Account Access**

With the changes to the DODD portal, we have posted updated instructions for *new* Early Intervention Data System (EIDS) users. These instructions are applicable to anyone who does not currently have EIDS access and who is seeking to obtain access to EIDS. There are two sets of instructions, as the steps to obtain access to EIDS vary based on whether the prospective user already has a DODD portal account. ## **Upcoming EIDS Changes for New EI Rules**

DODD is making a number of changes to EIDS as part of a general clean-up and to be in alignment with the new EI rules. These changes will be implemented in two phases. The first release will occur on January 24 and consists of changes needed to improve the end user experience and ensure consistency with current program requirements. The second release will occur when the new rules are implemented. Documents that outline the changes and new EIDS requirements in detail will be distributed ahead of the changes are made in EIDS. A summary of the changes expected to occur with the January 24 release follows.

- The child assessment items on the bottom portion of the assessment page will be rearranged to fall under two headings: (1) "Were the following included as part of the Child Assessment?" and (2) "Were the following domains assessed using this tool/method?" For the first set of questions, 'Yes' will need to be selected for at least two of the items in order to save the page.
- On the IFSP page, "IFSP Type" will be added as a required item. Additionally, the "Not applicable" dropdown option for the Child Outcomes Summary (COS) questions will be removed. Going forward, these items must be completed unless the IFSP is a periodic review, as indicated by the "IFSP Type" field. Finally, a "Resource Based Family Outcome" is being added as a dropdown option for "Service Type."
- Updates related to Transition section will be made. Required items regarding the Transition Planning Conference (TPC) will be added to indicate whether the child is potentially eligible for Part B and whether the family consented to the TPC. A tab will be added to document Transition Steps and Services in EIDS, including the date, NCR if applicable, and an open text field to document transition steps and services. Additionally, the Transition Prep tab will be removed.

• On the exit page, "Not applicable: IFSP is not an initial or annual IFSP" is being removed as a COS dropdown option. As it works now, this page will be able to be saved without entering information for the COS items if an IFSP was never completed for the child or the exit reason is "Child is deceased, "Loss of contact with family," or "Unable to contact family."

#### **New EI Rules and Forms**

The proposed new EI rules have been submitted to the Joint Committee on Agency Rule Review (JCARR). A public hearing will be held January 3. You can access the rules and forms and learn how to submit public comment on the EI website. We welcome your feedback.
