## May 1 LEA (applicable to all counties)

#### 2019 Family Questionnaire

# **DaSy COS Modules – Update**

The Center for IDEA Early Childhood Data Systems (DaSy) offers training on the Child Outcomes Summary via a series of online modules. They recently piloted a COS Competency Check (COS-CC), and we were able to provide CPDUs for those who completed the modules and passed the COS-CC.
