# May 1 LEA (applicable to all counties)

The May 1 LEA quarterly report requirement is approaching. The report may be run in EIDS no earlier than April 21, 2019 and must be sent to the appropriate LEAs no later than May 1, 2019. Please do *not* submit copies to DODD, but you are encouraged to maintain copies on file.

requests. Data cleaning instructions were attached to the April 17 email and county-specific reports listing applicable records were sent to participating counties April 19. Data will be extracted May 22.


#### **SFY19 Transition Analyses (Group 3)**
