PROGRAM UPDATES

Message from Our New EI Program Consultant: Henry Matthews

I am pleased to introduce myself as the newest member of the Early Intervention TA team. I am deeply committed to Early Intervention and am delighted to join a team that shares that same passion for EI. I hold a Master's degree in Early Childhood Development and Special Education from the University of Virginia, and I have spent the last five years working as a DS provider in Virginia. I was born and raised in Hilliard, Ohio, and I feel fortunate to have the opportunity to return to Ohio. During my time as a provider in Virginia, I worked both in the urban area of Norfolk (a densely populated city and home of the largest naval base in the country) and in two rural counties near the state line of West Virginia. New Training about Lead Exposure

We are pleased to announce the completion of a new course for EI service coordinators and interventionists related to childhood lead exposure. With the addition of confirmed elevated blood lead levels as an automatic eligibility diagnosis for EI on July 1, this course provides a helpful

overview of how children are exposed to lead, how lead test results are reported to the state, and resources available for lead abatement. We ask that all service coordinators take this course no later than December 31, 2019 so they are aware of the resources available for families on their caseloads. You can access the course (EI-073) on DODD's MyLearning. Additional professional development and other resources about childhood lead exposure will be made available throughout the year.

LEA Notification

The November 1 LEA quarterly report requirement is approaching. The report may be run in the Early Intervention Data System (EIDS) no earlier than October 22, 2019 and must be sent to the appropriate LEAs no later than November 1, 2019. Please do not submit copies to DODD, but you are encouraged to maintain copies on file.

If you are not sure which LEA should be selected for a specific child, we encourage you to contact the relevant Educational Service Center (ESC) for clarification. Contact information for all of the ESCs and Public School Districts, along with a map of districts, is available here:

SFY19 45-Day Analysis (Group 2)

Activities related to the SFY19 45-Day analysis are underway. Applicable county inquiries were sent September 5 and due back September 24. DODD is offering a clarification period, when applicable, and finalizing results over the next few weeks. Results memos will be sent in late October.

Forms and Parent Rights Translations

The new EI forms and updated parent rights brochure have been translated into the most frequently occurring languages among the families served in Ohio's EI program. The translated forms are all available in the "binder" format. You can access the translated parent rights brochures under the "Printed Materials" tile of the EI website.

MyLearning Server Issues

DODD IT has notified us of server issues with MyLearning. Completion of modules is not always being recorded, resulting in ability to obtain certificates. There have also been difficulties with modules not loading correctly. A MyLearning upgrade is in the testing phase with plans to launch in late October. It is expected these issues will be resolved with this launch.

Please review this message from IT about how to work around these issues in the meantime: Record of completion of the trainings is not always being recorded. Please ensure you are credited for your trainings by taking a screenshot of your completion screen. If the system does not update your course work properly please send your screenshot to ITSCallCenter@dodd.ohio.gov so that someone can fix your certificate so you can get a valid certificate. We are currently in the process of upgrading this system and once complete the issue will be resolved.

New Self-Care Resource for Service Coordinators

The 1-3-6 Journey for Children with Hearing Loss

The "1-3-6 Journey: is a free web-based training on OhioTrain (course #1085258) that stresses the importance of specialized EI services for infants and toddlers diagnosed with permanent hearing loss for the optimal development of communication, language, and social-emotional skills. This training shares the thoughts and feelings of two parents as their babies go through the journey of a non-pass hearing screening, diagnosis of hearing loss, and participation in Ohio's Early Intervention program. The training has been approved for continuing professional development units for EI service coordinators, service coordinator supervisors, developmental specialists, and EI supervisors.

Toilet Training for Children with Developmental Disabilities

This 2-day educational training coaches caregivers through toilet training children with developmental disabilities. Cost includes both classes and a training manual. Individual and/or intensive follow-up services are available if needed after class is completed.

Behavior and What It Means within a Relationship! -This presentation will provide an overview of the developmental and behavior models and their application to children in their early, formative years. We will look at the myriad of variables that can affect parent/child interaction and the relationships that are formed. Parenting application of the models and strategies will be discussed. Use of proactive, playful, co-regulating techniques are emphasized.
