FFY18 Annual Performance Report Posted for Public Comment

In the Spotlight: Transition Planning Conferences and the IFSP Grid

Under the new rules, the Transition Planning Conference (TPC) must be conducted during an IFSP meeting. OAC 5123-10-02(L)(2)(b). We have received questions about how to complete the Section 4 IFSP grid at the IFSP/TPC meeting.

Q: We completed an IFSP review and, two months later, we held the IFSP/TPC meeting. At the IFSP/TPC, nothing on the grid changed. The projected end date listed for the services was the child's third birthday, and we have already provided some of required visits. Do we have to do a new grid at the IFSP/TPC and if so, how?

A: If nothing changes on the grid that was completed at the IFSP meeting prior to an IFSP/TPC meeting, then you would review the outcomes and reflect the update at the bottom of each outcome page; and keep the same grid.

Q: We completed an IFSP/TPC meeting and added speech services. The child was already receiving special instruction and the projected end date for that service is the child's third birthday. How do we complete the new grid?

A: You would start a new grid but carry over the special instruction information from old grid and complete the grid with all the information needed to add speech services. PWN EI-11 is provided to the parent for the speech therapy and speech services must start within 30 days of the IFSP.
