The February 1 Quarterly LEA Report may be run no earlier than January 22, 2020 and must be sent to the appropriate LEAs no later than February 1, 2020. *You must also submit a copy of the report to DODD no later than Monday, February 3*. You are strongly encouraged to maintain a copy of the report in the event that it is needed at a later date for monitoring purposes.

# Understanding the behavioral language of the newborn and supporting parents as they get to know their new baby!

## **Newborn Behavioral Observation (NBO) Certification Training**



**The Newborn Behavioral Observations system (NBO)** is an *infant-focused, family-centered relationship-based tool,* designed to sensitize parents to their baby's competencies and individuality, in order to foster positive parent-infant interactions from the very beginning. The NBO is flexible and easily integrated into hospital, clinical or home visits. Recent studies show the NBO is associated with more optimal parent-infant interaction, provider confidence in meeting family needs, increased father involvement and reduction in post-partum depression symptoms

**Learning objectives:** provide trainees with information on neurobehavioral development and infant mental health, teach trainees how to administer the NBO and to review essential clinical skills in the implementation of the NBO system with families.

#### Trainee must meet the following criteria:

- DS or therapist (interventionist/assessor)
- Member of an IFSP team and serving infants and toddlers via IFSP
- Must commit to obtaining certification following training and using the information learned when assessing and providing interventions via the IFSP

#### **Dates and Locations:**

All sessions are two days in length. Hours are 8:30 a.m. to 4:30 p.m. both days.

The training is funded by DODD. The trainee is responsible for all costs associated with travel and lodging.
