PROGRAM UPDATES

COVID-19 and EI Monitoring

As DODD and EI providers continue to deal with the effects of the COVID-19 pandemic, we know that adjustments will be necessary to our baseline compliance monitoring calendar and analyses. At this time, we are focused on supporting counties in the all-important work of providing EI services to families. In the coming weeks, we will determine what adjustments are necessary, in conjunction with any guidance we receive from the federal Office of Special Education Programs (OSEP).

Eligibility Guidance during COVID-19

SFY 2020 45-Day Analysis (Group 1)

Records are currently being reviewed and clarification requests will be sent to counties, as applicable.
