PROGRAM UPDATES

May 1 LEA Reports

DODD e-mailed all EI contract managers and FCFC coordinators on April 8 about the May 1 LEA report due at the end of April. DODD understands that separating the PDF LEA report into individual files for each school district may be challenging with many people working remotely. In light of these challenges, we will be providing each county an Excel version of the May 1 LEA report that can be sorted and filtered by school district. You may continue to utilize and distribute the PDF versions of the report as usual, but, if you choose to use the Excel version for the May 2020 reporting, please ensure all relevant data are cleaned up and accurately entered into EIDS no later than *Monday*, *April 20*. DODD will extract the data and distribute the Excel files on April 21, along with instructions for how to sort and filter files by LEA. The appropriate LEA reporting information must be sent to LEAs no later than May 1.

Please remember the following requirements:

- The May 1 LEA report must be run no earlier than April 21 and no later than May 1.
- If the parent does not want contact information shared with the LEA, "no" must be selected in EIDS in response to "Transition contact info shared with LEA:" on the most recent IFSP and the date the parent declined to share information must be documented.
- It is expected that child information will be updated in a timely manner so that the LEA reports in EIDS are accurate.

- Only the sections of the report that are relevant to a particular LEA should be sent to that LEA, not the entire report.
- If you are not sure which LEA should be selected for a specific child, we encourage you to contact the relevant Educational Service Center (ESC) for clarification. Contact information for all of the ESCs and public school districts, along with a map of districts, is available here: https://education.ohio.gov/Topics/Data/Ohio-Educational-Directory-System-OEDS.

The May 1 LEA report does *not* need to be submitted to DODD, but we encourage you to keep a copy for your records. If you have any questions, please contact Melissa Courts at melissa.courts@dodd.ohio.gov.

SFY 2020 45-Day Analysis (Group 1)

Activities related to the SFY20 45-Day analysis are underway. Data were extracted February 24. Applicable missing data and verification requests were sent March 2 and were due back to DODD March 17. Records are currently being reviewed and clarification requests are being sent to counties, as applicable. DODD is currently evaluating its monitoring baseline procedures for SFY20 and anticipates adjustments in light of the COVID-19 pandemic.

Professional Development Requirements for the Infant Mental Health Credential

The goal of Ohio's Infant Mental Health credential is to implement a set of skills and core competencies that are developmentally appropriate and anchored in relationship-based practices that support the needs of infants and caregivers to reach their greatest wellness.

The credential has three levels:

- Ohio Infant Family Affiliate Level I (OIFA-I)
- Ohio Infant Family Practitioner Level II (OIFP-II), and
- Ohio Infant Mental Health Practitioner III (OIMHP III)

While no specific courses are required, there are required content areas and required hours for each level:

- OIFA-I: (20 hours required) Relationship-based training, child social-emotional development, maternal or infant health screening tools
- OIFP-II: (30 hours required) Relationship-based training, infant social-emotional development, maternal health, trauma, evidence-based interventions
- OIMHP-III: (40 hours required) Infant mental health, neurodevelopment, infant-family assessment, trauma, evidence-based treatment

Additional guidelines for trainings include the following:

• The training must be at least one-hour long. Trainings less than one hour will not display in the application.

- Up to three hours of a training will be applied. Only 3 hours of a training 3.5 hours or more will be applied to a content area.
- The training must be within that last six years. Trainings older than six years will not display in the application.
- A training can only apply to one content area.
