#### EISC Credentialing Update: DODD-OCCRRA Application Program Interface Is Live!

DODD's MyLearning and OCCRRA's Ohio Professional Registry (OPR) now "communicate" with each other via an API (Application Program Interface). This means that once an applicant successfully completes a training in MyLearning, notification of completion will automatically upload to the OPR. The EISC/EISC Supervisor will no longer need to upload certificates for courses completed within MyLearning. In order for the system to work, your first name, last name and email address in MyLearning must match exactly the information in your OPR profile. If you have not already done so, please update your OPR profile to match your MyLearning profile. Please note it takes 2-3 business days to process demographic changes and course verification.
