PROGRAM UPDATES

Documenting Method on the IFSP

Question: If a service will be addressing an outcome using two different delivery methods (inperson and technology) is it acceptable to list both delivery methods on the same line of the IFSP "Grid"?

Response: During the next several months, we will most likely experience shifting public health orders that will make it difficult to pinpoint the exact ratio of in-person/technology visits, and teams may choose to document both methods on the same line. If this type of documentation is implemented on the IFSP, the IFSP team needs to ensure the following:

- The child and family's needs can be met with a combination of in-person and technology visits
- Parents understand what it means to have two methods of service delivery listed on the grid of the IFSP and consent to what services will look like under the circumstances.
- EIDS reflects how the majority of services are occurring (either in person or via technology).

In some cases, it may make more sense to break out services on to two lines with one reflecting a virtual method and the other reflecting an in-person method. In all cases, EI service coordinators and service providers need to document clearly in case notes the conversation held during the IFSP meeting regarding service delivery. EI service coordinators and interventionists must comply with local Public Health Alert System guidelines, local advisories, and agency policies when considering in-person visits.

Annual Redetermination of Eligibility Reminders

For many children who entered early intervention during the pandemic and who were made eligible via informed clinical opinion (ICO), annual redetermination of eligibility will be due starting next month. DODD wanted to offer some tips and reminders about coordinating the annual redetermination of eligibility:

- Ensure the child's team is aware of when each child's annual evaluation/assessment is due and use information from ongoing assessment for program planning to inform annual redetermination/assessment (https://ohioearlyintervention.org/storage/ocali-ims-sites/ocali-ims-oei/documents/Annual-Assessment-and-Redetermination.pdf)
- If you are conducting an evaluation via technology, follow DODD's guidance on how to complete an evaluation virtually (https://ohioearlyintervention.org/storage/ocali-ims-sites/ocali-ims-oei/documents/EI-Eligibility-Process-during-COVID-19.pdf).
- Evaluations may be conducted up to 90 days prior to the annual IFSP due date.
- Eligibility does not need to be redetermined if a child was made eligible due to a delay of at least 1.5 standard deviations in any developmental domain or if the child was made eligible because of a diagnosis on the list (5123-10-02 Appendix C)
- Children who are within 90 days of their third birthday are not required to participate in the annual redetermination of eligibility.

New and Updated EIDS Guidance Documents

DODD has created a supplement to the EIDS Data Entry Guide that provides additional information about data entry scenarios where DODD frequently receives questions from EIDS users. The supplement includes information about the following:

- Data entry order
- Eligibility via a Very Low Birth Weight diagnosis
- Documenting additional eligibility information
- Transferring a record
- Requirements in transferred records
- Requirements in a record with an exit and subsequent referral
- Entering services in EIDS, including
 - o Entering multiple outcomes
 - o Entering service start dates
 - o Entering a new IFSP when services from the previous IFSP have not started
 - o The frequency dropdown limitation of the "Add New Service" box

DODD also made updates to three existing EIDS guidance documents. The "EIDS Troubleshooting, Edits, and Other Assistance" document replaces the previous EIDS Troubleshooting document and includes more comprehensive information regarding troubleshooting issues in EIDS. This document also includes a table that outlines the levels of access EI Service Coordinators and System Administrators have in EIDS, indicating whether they can read, add, or update information on each page. The "Adding and Modifying EIDS Accounts"

document was updated to include a list and description of available EI roles. The "EIDS Data Entry Guide" was updated to include a description of each of the other EIDS guidance documents and updated screenshots of the Caregiver page that show the newly required email address field. SFY21 Timely Receipt of Services (TRS) Baseline

Activities related to the SFY21 TRS baseline analysis are underway. Results memos are scheduled to be sent March 19.

SFY21 45-Day Baseline

Activities related to the 45-Day baseline analysis are underway. DODD extracted data for the baseline analysis on February 16 and sent enquiries to applicable counties on March 4. These are due back on March 22. Contact Melissa Courts at melissa.courts@dodd.ohio.gov if you have any questions.

SFY21 Transition Baseline

Activities related to the SFY21 Transition baseline analysis are underway. DODD sent emails notifying counties about their inclusion in the analysis on March 9. Applicable counties have until March 24 to make any needed edits to data, including requesting deletions. Data for the baseline analysis will be extracted April 2.

EI Communication Toolkit

Bright Beginnings presented a webinar on the EI Communication Toolkit on February 4. This 60 minute webinar covered the toolkit's messaging, 4 templates, and resources to raise awareness and build outreach efforts for EI services in your county. A recording of the presentation is available here:

Principles of Service Coordination

We are pleased to announce the launch of Module 1 of the Principles of Service Coordination (POSC) on MyLearning. POSC has been converted to a fully self-paced format and consists of eight modules. Pursuant to Chapter 119. of the Revised Code, the Ohio Department of Developmental Disabilities hereby gives notice of its intent to rescind and adopt rules of the Administrative Code on a permanent basis and to conduct a public hearing thereon. At this public hearing, the Department will accept verbal and/or written testimony regarding the proposed rule actions.

Persons unable to attend the public hearing may submit written comments regarding the proposed rule actions. Any written comments received on or before the public hearing date will be treated as testimony and made available for public review. The Department plans to rescind rule 5123:2-5-05 and adopt replacement rule 5123-10-05 on or about July 1, 2021.

Rule 5123:2-5-05 (Early Intervention Services Certification Standards) establishes minimum qualifications through certification standards for staff employed as Developmental Specialists or Early Intervention Supervisors. The rule is due for five-year review. The Department engaged stakeholders to comprehensively review the rule and make recommendations. Based on that effort, the Department is rescinding rule 5123:2-5-05 and adopting replacement rule 5123-10-05 (Early Intervention Program - Developmental Specialist Certification). Rule 5123-10-05 establishes minimum qualifications through certification standards for persons employed as Developmental Specialists and sets forth the path for persons holding Early Intervention Supervisor certification to receive Developmental Specialist certification.

The Department plans to rescind rule 5123:2-2-01 and adopt replacement rules 5123-2-08 and 5123-2-09 on or about September 1, 2021.

Rule 5123:2-2-01 (Provider Certification) establishes procedures and standards for certification of providers of supported living services, including Home and Community-Based Services provided in accordance with Section 5123.045 of the Revised Code. The rule is due for five-year review. The Department engaged stakeholders to comprehensively review the rule and make recommendations. Based on recommendations by stakeholders, the Department is rescinding rule 5123:2-2-01 and adopting two replacement rules:

- 5123-2-08 (Provider Certification Agency Providers) and
- 5123-2-09 (Provider Certification Independent Providers). Rule 5123-2-08 establishes procedures and standards for certification of Agency Providers of supported living services, including Home and Community-Based Services provided in accordance with Section 5123.045 of the Revised Code. Rule 5123-2-09 establishes procedures and standards for certification of Independent Providers of supported living services, including Home and Community-Based Services provided in accordance with Section 5123.045 of the Revised Code.

The rules are available for review at the Register of Ohio website (http://registerofohio.state.oh.us) and at the Department's website (https://dodd.ohio.gov/wps/portal/gov/dodd/forms-and-rules/rules-under-development/public+hearings+for+proposed+rules). The rules are also available for review at each county board of developmental disabilities.
