### PROGRAM UPDATES

### SFY21 45-Day Baseline

Activities related to the 45-Day baseline analysis are underway. Compliance inquiries were sent to applicable counties on March 4 and were due back March 22. Any needed clarification and final analyses will be completed over the next month and results memos will be sent May 11. #### **SFY21 Transition Baseline**

Activities related to the SFY21 Transition baseline analysis are underway. Applicable counties had until March 24 to make any needed edits to data, including requesting deletions, and data for the baseline analysis were extracted April 2. Data inquiries will be sent to applicable counties by April 16 and due back to DODD by May 5.

### May 1 Local Educational Agency (LEA) Reporting Requirement

The quarterly LEA reporting requirement is coming up at the end of the month. This report is now available in the EI Data System (EIDS) in both Excel and PDF formats. You may use either version, but please remember the following:

- The May 1 LEA report must be run no earlier than April 21 and no later than May 1. If the parent does not consent to share contact information with the LEA, "no" must be selected in EIDS in response to "Transition contact info shared with LEA:" on the most recent IFSP and the date the parent declined to share information must also be documented.
- It is expected that child information will be updated in a timely manner so that the LEA reports in EIDS are accurate.

- Only the sections of the report that are relevant to a particular LEA should be sent to that LEA, not the entire report.
- If you are not sure which LEA should be selected for a specific child, we encourage you to contact the relevant Educational Service Center (ESC) for clarification. This quarterly report must be provided to the LEAs no later than May 1. The report does not need to be submitted to DODD, but we encourage you to keep a copy for your records. If you have any questions, please contact Melissa Courts at melissa.courts@dodd.ohio.gov.

### **Entering Virtual Evaluations in the EI Data System (EIDS)**

Over the past several weeks, DODD has analyzed evaluation data counties have entered into the EIDS. This analysis suggested that many evaluations had been completed in-person rather than virtually because of the presence of scores showing a delay in the cognitive, communication, and physical domains. However, we know from survey data from the autumn that most evaluations were being completed virtually in the state. Each county was sent a file last week including all evaluations completed and entered in EIDS from March 5, 2020 through March 18, 2021 and asked to review and edit evaluation scores in some circumstances. System Administrators can adjust evaluation scores in any record (even if the record has been exited) unless the record has been transferred. All applicable evaluation scores must be adjusted and completed files must be returned to EI program consultants by April 14.

### Newborn Behavioral Observations (NBO) Training Registration Open!

We are pleased to announce that registration is available for training on the NBO tool. The NBO is an infant-focused, family-centered tool designed to enhance the parent's understanding of their infant's strengths and to foster infant-parent relationships. Developed by Dr. Kevin Nugent and

colleagues at the Brazelton Institute, the NBO was inspired by the work of Dr. T. Berry Brazelton at the Brazelton Touchpoints Center. The NBO is guided by the principle that "the quality of early experiences drives brain development and functional outcomes." ### What is an Early Intervention Service Coordinator (EISC)/EISC Supervisor – 5-Year "Transition" Credential?

To recognize the experience of EISCs/EISC Supervisors with active credentials prior to rule change in 2019, the transition credential was established to provide special criteria for the changeover from the previous credentialing rule to Ohio Administrative Code 5123-10-04. The transition credentials are only available to EI service coordinators/EI service coordination supervisors who hold an unexpired credential issued prior to July 1, 2019. The requirements to obtain the credentials take into account:

- Previous experience as an EISC/EISC supervisor
- Educational and employment information previously documented within the OPR
- Option to test out of modules 1-5 of Principles of Service Coordination
- Prior completion of the service coordination skills inventory

The transition credential and the five-year regular credential do not represent two different levels of credential. They are equivalent in terms of meeting the requirements to practice as an EISC/EISC Supervisor.

### Principles of Service Coordination Course Verification and Your OCCRRA Profile

We recently launched the self-paced Principles of Service Coordination (POSC) course on MyLearning. The course has eight modules. When you successfully complete a module, the completion transfers to the Ohio Professional Registry (OPR) via an Application Programming Interface (API). You do not need to upload a certificate or transcript.

However, there is a different process if you test out of a module. Modules 1-5 have a test out option available for EISCs who held an active EISC credential prior to July 1, 2019. If you test out, the API does not recognize these completions. You will need to upload your transcript for each module for which you test out. As a reminder, CPDUs are not provided for any module for which you test out.

### **Emergency Broadband Benefit**

The Emergency Broadband Benefit is a Federal Communications Commission (FCC) program to help households struggling to pay for internet service during the pandemic. This new benefit connects eligible households to jobs, critical healthcare services, and virtual classrooms. The Emergency Broadband Benefit will provide a discount of up to \$50 per month towards broadband service for eligible households. Eligible households can also receive a one-time discount of up to \$100 to purchase a laptop, desktop computer, or tablet from participating providers if they contribute \$10-\$50 toward the purchase price.
