PROGRAM UPDATES

2021 EI Family Questionnaire Distribution

DODD will be distributing the annual EI Family Questionnaire in early August to families who were served in EI on June 1, 2021. DODD again plans to collect the majority of responses online and will be emailing the Family Questionnaire information sheet and a link to complete the questionnaire directly to primary caregivers who have an email listed in EIDS. If an email address is not listed in EIDS, DODD will mail the information sheets and a physical survey to the family. In order to streamline data collection as much as possible, we ask that EI service coordinators attempt to collect email addresses for any caregiver who does not currently have one listed in EIDS, but does have an email account and is willing to share it. Data for the June 1 child count will be extracted July 1, so please be sure any email addresses are added, as applicable, by June 30.
