Contact Change

SFY21 EI Service Coordination Grant Agreement Final Program Report

DODD e-mailed all FCFC coordinators and EI contract managers on July 1 about the final SFY21 program report. As a reminder, you must complete the local EI outreach spreadsheet and submit one story about a family you served in EI. Please e-mail these items to your EI program consultant no later than July 31.

August 1 LEA Reporting

The quarterly Local Educational Agency (LEA) reporting requirement is coming up at the end of the month. The report is available in EIDS in both Excel and PDF formats. You may use either version, but please remember the following:

• The August 1 LEA report must be run no earlier than July 22 and no later than August 1. If the parent does not consent to share contact information with the LEA, "no" must be selected in EIDS in response to "Transition contact info shared with LEA:" on the most recent IFSP and the date the parent declined to share information must also be documented.

- It is expected that child information will be updated in a timely manner so that the LEA reports in EIDS are accurate.
- Only the sections of the report that are relevant to a particular LEA should be sent to that LEA, not the entire report.
- If you are not sure which LEA should be selected for a specific child, we encourage you to contact the relevant Educational Service Center (ESC) for clarification. Contact information for all of the ESCs and public school districts, along with a map of districts, is available here: <u>http://education.ohio.gov/Topics/Data/Ohio-Educational-Directory-System-OEDS</u>

This quarterly report must be provided to the LEAs no later than August 1. The report does not need to be submitted to DODD, but we encourage you to keep a copy for your records. If you have any questions, please contact Melissa Courts at <u>melissa.courts@dodd.ohio.gov</u>.

System of Payments Updates

Effective July 1, DODD made several changes to SOP provider agreements. Of particular note for local EI systems, SOP providers can now bill for participation in IFSP meetings and quarterly EI team meetings. As a reminder, any potential EI provider should be invited to an IFSP meeting, and we encourage you to invite SOP providers in your county to the quarterly EI team meeting when a child they serve is being discussed. 2021 EI Family Questionnaire Distribution

DODD will be distributing its annual Family Questionnaire in early August to families who were served in EI on June 1, 2021. DODD again plans to collect the majority of responses online and will be emailing the Family Questionnaire information sheet and a link to complete the questionnaire directly to primary caregivers who had an email address listed in EIDS at the time the June 1, 2021 child count data were extracted. If an email address was not listed in EIDS, DODD will mail the information sheets and a physical survey to the family.

In order to obtain as many responses as possible, we will again ask that EISCs reach out to families on their caseload who receive the survey encouraging them to respond. The recipient list will be finalized in the coming weeks and a list of recipients in each county will be distributed to Contract Managers and FCFC coordinators at that time.
