PROGRAM UPDATES

SFY22 LEA Notification Baseline

The February 1 Quarterly LEA Reports are used for the state's annual compliance analysis related to LEA notification. DODD is responsible for issuing findings of noncompliance in this area where appropriate. The February 1 Quarterly LEA Report may be run no earlier than January 22 and must be sent to the appropriate LEAs no later than February 1. You must also email a copy of the full report to DODD no later than Wednesday, February 2. Submit reports to melissa.courts@dodd.ohio.gov. You are strongly encouraged to maintain a copy of the report in the event that it is needed at a later date for monitoring purposes. DODD sent an email explaining the LEA reporting requirement to all EI contract managers and FCFC coordinators on January 6. Please remember that parent rights apply to any shared information if personally identifying details are disclosed. Only applicable pages of the report should be sent to each LEA.

Evidence-Based EI Practices Re-boot
