

#### Social Worker License Number Field in MyLearning


MyLearning users now have the option to enter their Social Worker license number into their MyLearning accounts. Individuals who seek continuing education units for the Social Work board must utilize this option so that their Social Worker license number populates onto their certificates for the MyLearning courses approved for Social Work credit. *Individuals who are not licensed social workers should leave this field blank*. The blank field in MyLearning will show as "N/A" on the user profile and the certificate.

After you have logged into DODD MyLearning, click <u>here</u> to view the MyLearning courses that are approved for Social Work credit. *Keep in mind that these courses will only be approved for Social Work credit if they were completed on or after May 16, 2023.* 

To enter your Ohio Social Worker license number, first navigate to your MyLearning Profile by selecting "Profile" under the arrow in the top right corner.
