#### **PROGRAM UPDATES**

SFY24 Transition Compliance – Local Educational Agency (LEA) Notification

We have analyzed SFY24 data related to notification to the LEA of children potentially eligible for Part B services as required by 34 CFR section 303.209(b)(1). Results memos will be sent in the coming weeks.

#### SFY24 45-Day Baseline

The EI monitoring team is reviewing submitted inquiries requesting clarification and incorporating results for the SFY24 45-Day baseline. We anticipate sending results memos by March 26.

#### SFY24 Timely Receipt of Services (TRS) Baseline

Data for the SFY24 TRS baseline analysis were extracted on March 1. Applicable county inquiries will be sent by March 14 and will be due back to the EI monitoring team by March 29. #### SFY24 Transition Baseline

A resource to help families recruit home care nurses for their loved ones with complex medical needs.

All nursing services (Registered Nurse (RN)) or a Licensed Practical Nurse (LPN) require a current license and a Medicaid provider agreement with the Ohio Department of Medicaid.

## **Private Duty (PDN) Nursing**

Independent Provider (IP) who is a Registered Nurse (RN) or Licensed Practical Nurse (LPN) that serves people through the Medicaid State Plan:

- RN \$46/first hour and \$11.50/15 minute units thereafter
- LPN \$38.88/first hour and \$9.72/15 minute units thereafter Contact: ODM Integrated Helpdesk (IHD) at 800-686-1516 or IHD@medicaid.ohio.gov

## **Individual Options (IO) Waiver Nursing**

Requires certification by the Ohio Department of Developmental Disabilities (DODD) using the same process as described for PDN.

IO Waiver nursing is authorized for people who require a nurse when State Plan Home Health Nursing or PDN is unable to meet all of the person's nursing needs.

- RN \$56.26/first hour and \$7.46/15 minute units thereafter\*
- LPN \$48/first hour and \$6.24/15 minute units thereafter\* Contact: 800-617-6733 or Providers | Department of Developmental Disabilities (ohio.gov)

## **Ohio Home Care Waiver Nursing**

- RN \$55.26 first hour and \$7.46/15 minute units thereafter
- LPN \$48 first hour and \$6.24/15 minute units thereafter Contact: ODM Integrated Helpdesk (IHD) at 800-686-1516 or IHD@medicaid.ohio.gov
