#### *SFY24 Transition Baseline*

#### *Family Questionnaire Quantitative Reports*

Quantitative analyses of the 2024 Family Questionnaire are complete. Percentages of positive responses remained high statewide for all items. DCY sent a quantitative report, including the county's results for each item and the county's response rate, to each EI Contract Manager and FCFC Coordinator on July 17. A document including all county reports has been posted on the EI website (<https://ohioearlyintervention.org/county-data>) and each county report has been posted on the individual county report page.

We are reviewing all comments in the open-ended questions, removing identifying information if the parent did not consent to share their comments exactly as written, and following up with any families as needed. Once the comment review is complete, we will send each county a file with all the responses to open-ended items from families in their counties. These files will not be posted publicly.
