EI-03 Prior Written Notice of Eligibility Determination Guidance and Samples

The EI-03 Prior Written Notice of Eligibility Determination form has *not* changed. The guidance, samples, and video have been updated to include new requirements when completing this form. Moving forward, the "Summary of Evaluation Findings" section of this form is required for all children who receive a developmental evaluation. Reminder Regarding Early Intervention MyLearning Certificates and OCCRRA

MyLearning and OCCRRA are connected via an Application Programming Interface (API). If MyLearning users have entered their names, email addresses, and OPINs correctly into their MyLearning profiles, their courses should automatically be transferred to their OCCRRA Professional Development tabs.

This process means that OCCRRA users should *not* manually submit Early Intervention MyLearning certificates into OCCRRA. These manual course entries will *not* be verified. Courses taken outside of MyLearning should continue to be manually submitted to await verification by OCCRRA.
