PROGRAM UPDATES

SFY24 Summary Data

The SFY24 annual summary report has been posted on the EI website here:

This report contains referral sources, children served, eligibility reasons, services on initial Individualized Family Service Plans (IFSPs), and exit reasons. County reports with the same information were sent to EI Contract Managers and FCFC Coordinators on August 21st.

Documentation of Visits

Only service visits that *occurred* should be documented as "completed" when tracking service provision (e.g., visit 4/12). If a service visit is cancelled, the service provider should document all details regarding the cancellation and the cancelled visit does not count in the total number of visits. The service provider should attempt to reschedule the visit as soon as possible and document all communication related to attempts to reschedule. Documentation should include dates/times offered to the family, dates declined, scheduling limitations, etc. If visits are consistently missed or rescheduled, an IFSP review may be needed to update the service information.

Did You Know? - Evaluation Requirements

As a reminder, evaluations must be completed via the use of an approved tool, which include the Bayley or Battelle in Ohio. The evaluation must meet the requirements of the tool administration, including the requirements that at least one evaluator must be trained on the tool and that at least one evaluator must administer the tool in person.

45-Day Verification Standards

OCALI has limited training slots available for Early Intervention professionals serving children with autism or suspected autism to pursue PLAY Project autism intervention certification. Professionals must be able to serve as a primary service provider (PSP) and commit to an 18-month training and supervision period. Infant Hearing Program Parent-to-Parent Support

The Infant Hearing Program within the Ohio Department of Health (ODH) tracks the hearing status of Ohio residents age 0-36 months and program staff may reach out to parents for recommended Audiology testing or referral to Early Intervention. Additionally, parents can now reach out to a parent consultant, who is a parent of a child with hearing loss, to ask questions, receive resources, and/or talk to a non-medical person who can assure them they are not alone in navigating their child's hearing loss.
