Did You Know? - Ohio Professional Registry (OPR) Profile Creation

Before EISCs, EISC Supervisors, or Developmental Specialists (DSs) can submit their credentialing/certification applications in the OPR, they must create a *complete* OPR profile. Creating a complete OPR profile includes adding employment and uploading official college transcripts in the "Education" section. Ohio Child Care Resource and Referral Association (OCCRRA) may take up to 30 business days to review college transcripts, and professionals may not submit their credential/certification applications until their transcripts have been verified.

We encourage all new EISCs and DSs to create a complete OPR profile and upload the required documents immediately upon starting their position. New EISCs and DSs may work on their orientation modules and other onboarding procedures while OCCRRA processes and verifies their college transcripts. Completing an OPR profile and uploading the required information upon being hired helps to ensure that new EISCs and DSs are able to submit their credential/certification applications as soon as possible.
